

# From Mandate to Movement:

How Funders Can Support Equitable Open Access in the Global South

**Call For Action** 

- Funders: Move beyond mandates to sustained engagement
- Researchers & librarians: Advocate for equity-focused OA policies
- Governments: Align national science policy with open access goals

**Together:** OASPA shapes policy and standards, DOAJ ensures discoverability and quality enabling funders to move from mandate to movement in the Global South

#### **Anticipated Impact**

- Greater visibility of Global South research
- Knowledge equity: inclusion in global policymaking
- Sustainable, community-owned publishing ecosystems

Mandates are not just rules - they are opportunities for equity in Open Access




# Reimagining Equity and Inclusion in Open Access Publishing

Pricing power parity is **an innovative strategy** to **set prices based on regional purchasing power**. In January 2025, we've launched a 12-month pilot for authors from Latin America across our gold OA journals to improve OA equity through regionally adjusted APC pricing.

### What we've learned so far:

- Significant increase in gold OA manuscript submissions from pilot countries, with the highest growth coming from Brazil.
- Other countries showing increased submissions include Argentina, Chile, and Guyana.
- Revenue and accepted article trends are still emerging but are trending positively.
- Marketing activities and society support to help increase author awareness has been important for pilot success.



By aligning publishing charges with regional economic realities, we're committed to transforming the research landscape from one of privilege to one of possibility.




